ur most redoughted puyssant and myghty prynce our most drad belovyd and naturall Soveraign lorde

We your poore humble and most obedyent Subject f the Mayre Aldermen and Comminaltye of your Citye and chamber of London dayly confyderyng and evermore and more perceyvyng by your vertuouse begynnyngf and charitable procedyng f in all your affayres that your maje stie Royall ys the elect and chosen vessell of god by whome not alonely hys true worde ys and shalbe set forthe and utteryd accordyng to the truthe and verytie of the Same but also to be the Self Same person whome god hath constytuted and ordeignyd bothe to redresse and reforme all crymes offences and enormytyes beyng repugnant to hys doctryne or to the detryment of the common welth and hurte of poore people beyng your naturall Subjects and also to See and vigillantly to provide for the reformacion of the Same

Whiche your godly and gostly mynde with your charytable procedyng yn all causes Dothe not a lytell animate and encourage us your fayd orators to fue to your grace with most humble harte for two petycions very necessary as we thynke for the commen welth and the proffytt and commodytie of your Cyttzyns and all other repayryng to your Cytie.

Wherfore it may please your mercyfull goodnes ever enclyned to pytie and compassyon for the Relyef of crystes very Images creatyd to hys owne Symlytude to order and establyshe by graunte or otherwyse, by your most vertuous and Sage dyscrecion that the mayre and hys brethren of your cytye of London or Suche other as shall stande with your most gracyous favor shall and may from hensfurthe have the order rule dysposicion and governance of all the Sayd hospytalls and Abbey with the rentf and revenous apperteyning to the Same for the onely relyeff of the poore Sykke and nedy persones trustyng that your grace shall facylye perceyve that where nowe a Smalle nombre of chanons preestes and monks be founden for theyr owne Synguler proffytt lucre and commodytye onely and not for the common utyllytye of thys your Royalme a greatter nombre of poore nedy Sykke and indygent <u>perfones</u> shalbe refresshed maynteyned comforted fownde heled and cured of theyre infyrmytyes frankely and frely by phisicions Surgeons & Appotycaryes whiche shall have Stypende Salary and wages onely to attende for that entent and purpose so that all impotent persones not hable to labor shalbe releved by reason of the Sayd hospitalles and Abbey and all Sturdy beggers not wyllyng to labor shalbe puniffhed so that with godds grace fewe or no per-For the helpe of the Sayd poore people we Sones Shalbe Seene abrode to begge or aske almesse;

For the redresse of the Same pleasyth yt your highnes to call to your pryncely remembrance that where certayn relygyous persones late callyd Freers founded by the byffhop of *Rome* hys usurped Authorytye and not of goddes worde under color of Symplicitie and wylfull povertie have procured theym Selffes houses churches and other places withyn thys your Sayd Cytye by reafon of whose ample and large chyrches there was no provy (you made yn the poore and smalle paryffhe churches for Severing of Sykke and infected persones from the hole and Sondry people consyderyng that in the chyrches of the Said Freers were masses erely and at all howres and the Sayd chyrches large and brode At whiche tyme the Sayd persones infected dyd commonly thether resorte without daunger of other
