George the Third by the Grace of God of  
Great Britain France and Ireland King De-  
fender of the Faith &c.

To all and singular Archbishops Bishops Arch-  
deacons Deans and their Officials Parsons  
Vicars Curates and all other spiritual persons  
and To all teachers and preachers of every sep-  
erate Congregation

and also To all Justices of the peace Mayors  
Sheriffs Bailiffs Constables Churchwardens  
Chapemwardens Headboroughs Collectors for  
the poor and their Overseers

and also To All Officers of Cities Boroughs and  
Towns Corporate

and to All other our Officers Ministers and  
Subjects whomsoever they be as well within  
Liberties as without

To whom these presents shall come Greeting

Whereas it hath been represented unto Us  
as well upon the humble Petition of John  
Thornton Fowler Walker and Jonas Hanway  
Esquires for and in Behalf of the Sufferers by  
Fire at Montreal in the province of Quebec

as by a Certificate of his Excellency the Honour-  
able James Murray our Governour of that prov-  
ince under the Seal of the said province

That on the Eighteenth of May in the fifth Year of  
Our Reign happened a most dreadful and rapid  
Fire at Montreal aforesaid which in the Space of  
about Three Hours consumed One hundred and  
Eighty Dwelling Houses inhabited by Two hun-  
dred and fifteen Families with their Merchandise  
Furniture Wearing Apparel some plate and paper  
Money to the Amount of Eighty seven Thousand  
five Hundred and Eighty pounds eight Shillings  
and Ten pence Sterling

And That the poor Sufferers are a Loyal Obedient  
and laborious people and before this dreadful Ac-  
cident were recovering from the Calamities of  
War and the Suspension of their Trade and well  
inclined to assist each other

but so Many of them are now reduced to the  
utmost Distress that if not relieved by their Fellow  
Subjects here Many Families will be unavoidably  
involved in and exposed to the greatest Misery

Wherefore the said poor Sufferers have joined  
together and most humbly besought Us to grant  
unto them our most gracious Letters patent Li-  
cense and protection under Our Great Seal of  
Great Britain to empower them to ask collect and  
receive the Alms Benevolence and charitable  
Contribution of all our Loving Subjects from  
House to House throughout England the Town of  
Berwick upon Tweed and our Counties of Flint  
Denbigh and Radnor in Wales

Unto which their humble Request We have graci-  
ously condescended not doubting but that when  
these presents shall be made known to our loving  
Subjects they will readily and cheerfully contrib-  
ute To the Relief of their poor suffering Brethren

Know ye therefore That of our especial Grace  
and princely Compassion We have given and  
granted and by these our Letters patent under our  
great Seal of Great Britain We do Give and grant

unto the said Petitioners and to their Deputy and Deputies the Bearer and Bearers hereof (authorized as is herein after directed) full power Licence and Authority to ask collect and receive the Alms Benevolence and charitable Contribution of all our loving Subjects within all and every our Counties Cities Towns Boroughs Hamlets Cinqueports districts parishes Chapelries and all other places whatsoever from House to House throughout England our Town of Berwick upon Tweed our Counties of Flint Denbigh and Radnor in Wales for the Relief of the said poor Sufferers

[2] And therefore in pursuance of the Tenor of an Act of Parliament made in the fourth year of the Reign of Queen Ann intituled *An Act for the better collecting Charity Money on Briefs by Letters Patent and preventing Abuses in relation to such Charities* [2] Our Will and pleasure is and We do hereby (for the better Advancement of these our pious Intentions) require and command all Ministers Teachers and preachers Churchwardens Chapelwardens and the Collectors of this Brief and all others concerned That they and every of them

observe the Directions in the said Act contained and

do in all things conform themselves thereunto

and that when the printed Copies of these presents shall be tendered

unto you the respective Ministers and Curates Churchwardens and Chapelwardens and

to the respective Teachers and preachers of every seperate Congregation and

to any person who teaches or preaches in any Meeting of the people called Quakers

that you and every of you under the penalties to be inflicted by the said Act do receive the same And

you the respective Ministers and Curates Teachers and preachers and persons called Quakers are by all persuasive Motives and Arguments earnestly to exhort your respective Congregations and Assemblies to a liberal Contribution of their Charities for the purpose aforesaid And

you the Churchwardens and Chapelwardens together with the Minister or some of the substantial Inhabitants of the several parishes and Chapelries and of all other places whatsoever within all and every our Counties throughout England our Town of Berwick upon Tweed our Counties of Flint Denbigh and Radnor in Wales are hereby required

to go from House to House upon the Week Days next following the publication of these presents to receive from the Inhabitants their Christian and charitable Contribution and

to take the Names in Writing of such as shall Contribute thereunto and the Sum and Sums by them respectively given and indorse the whole Sums upon the said printed Briefs in Words at Length and subscribe the same with your own proper Hands together with the Name of the parish or place where and the Time when collected and

to enter the same in the publick Books of Account kept for each parish and Chapelry respectively And

the Sum and Sums collected together with the said printed Briefs so indorsed you are to deliver to the Deputies and Agents authorized to receive the same

And We do by these presents nominate constitute and appoint

and regular Collection of this Brief and Ad-  
vancement of the said Charity and

to see that the Monies when collected be paid to  
the said poor Sufferers respectively in propor-  
tion to their respective Losses

[4] And Lastly Our Will and pleasure is That no  
person or persons shall collect or receive any the  
printed Briefs or Monies collected thereon but  
such only as shall be so deputed and made the  
Bearer and Bearers of these presents or Duplicates  
thereof

In Witness Whereof We have caused these our  
Letters to be made patent and to continue in Force  
for one whole Year from Lady Day next [3] and no  
longer

Witness Ourselves at Westminster the Second Day  
of July in the Sixth Year of our Reign. [4]
